This License Agreement is entered into between the Trustees of the California State University by San José State University, hereinafter called "University" and the individual whose name appears on the above, hereinafter called "Licensee". In consideration for the right to occupy an assigned bed space within the housing facility at the University, Licensee hereby agrees to make payments to the University in accordance with the payment plan and/or meal plan selected on the Assignment Information Form.

Licensee and University agree to adhere to the terms and conditions set forth in the 2009-2010 Annual Student Housing License Agreement Booklet. This contract is valid during the time period indicated below and legally obligates the Licensee to full payment of fees for the licensed period. If this debt is referred to a private collection agency, then the Licensee is responsible for paying any reasonable collection costs.

For the Apartments Academic Year, this License Agreement covers the entire academic year August 22, 2009-May 26, 2010. It does not include the summer period.

(initial) _____ **The Apartments Year Round**

For the Apartments Year Round, this License Agreement covers the 10 month period beginning August 7, 2009-May 31, 2010. It does not include the summer period, unless Licensee is assigned to and signs an addendum for a summer apartment, in which case there is an additional fee as indicated in the Annual Student Housing License Agreement Booklet.
